Mini-trainings in prisons

Achievements

1 Quarter

According to the planned activities AFEW Tajikistan obligated to conduct series of informational mini-trainings on HIV prevention among prisoners on HIV, TB and drug use. During the first quarter AFEW-Tajikistan established the system and the mechanism of provision of mini-training in the prisons settings (introduction of unique coding system, pre and post knowledge evaluation). Primary the mini-trainings were organized as short provision of information based on the AFEW mini-training module. The trainings organized by AIDS civil health center of Khatlon region.

Thus, AFEW Representative Office in Khatlon region in October-December, 2014 conducted 8 mini-trainings among 160 prisoners including 80 female prisoners. Mini-trainings on HIV prevention were conducted among prisoners in colony 3/6 in Yovon and in female colony 3/8 in Norak.

2 Quarter

Starting from the second quarter AFEW-Tajikistan decided to provide HIV testing in the prisons settings after minitraining. There was an agreement with regional AIDS center to provide prisoners with express test and HTC. After minitraining the training participants i.e. prisoners were suggested to pass HTC on voluntary based. This effort made possible to detect HIV among prisoners and thereby decrease the number of HIV transmissions in prisons.

Thus, AFEW Representative Office in Khatlon region in January-March, 2015 conducted 4 mini-trainings among 80 prisoners including 40 female prisoners. Also 25 HTC was organized among 25 prisoners and 43 prisoners received

medical consultation of health specialists.

3 Quarter

As prisons face a problem of absence qualified medical personnel AFEW-Tajikistan decided to involve the civilian health specialist to monitoring activities. The specialist of infectious diseases of the Republican AIDS center visited colonies 3/6 in Yovon and 3/8 in Norak. The specialist met patients, checked all medical cards of patients of colonies and made all necessary recommendations to primary medical staff of colonies.

In the period of April – June 2015 AFEW Representative Office in Khatlon region conducted 9 mini-training among 180 (80f/100m) prisoners. As well in this period 29 prisoners of both colonies were tested for HIV and 30 prisoners received medical consolations of specialists.

2 new case of HIV were detected.

4 Quarter

In the last quarter of Year I - July-September 2015 AFEW Representative Office in Khatlon region conducted 7 minitraining among 140 (60f/80m)prisoners. As well in this period 12 prisoners of both colonies were tested for HIV and 14 prisoners received medical consolations of specialists.

2 new case of HIV were detected.

Conclusions of the Year:

For the first year of project realization AFEW Tajikistan covered 600 (280f/320m) prisoners with HIV prevention minitrainings. 95 prisoners received consultations of medical specialists and 66 prisoners received HTC. 4 new cases of HIV were detected and 10 cases were confirmed.

In compliment to above mentioned information presented based on quarters AFEW-Tajikistan organized series of trainings for personnel of penitentiary system for improving situation in prisons as razing the tolerance attitude towards HIV infected, PLHIV and PUDs; providing better and accessible services for prisoners with the main focus to HIV infected, PLHIV and PUDs:

- 1. Six trainings on "Basis of organization of mini-trainings on HIV prevention among prisoners" were conducted in Dushanbe, Yovon, Norak and Khujand for 144 non-medical workers of six colonies. Informational sessions were organized by AFEW-Tajikistan and facilitated by educated specialists of AIDS Centers of Dushanbe, Khatlon and Sughd regions. (Quarter 1)
- On 30-31 of March "Drug treatment, MAT and social rehabilitation" training was conducted in Dushanbe for 21 medical representatives from prisons, drug treatment center, AIDS center and public organizations.
 Training was organized in Dushanbe. (Quarter 2)
- 3. Three two-days trainings on "Networking and Rules of Law" for 63 law enforcement officers NGOs and service providers have been conducted for law enforcement officers (Quarter 2)
- 4. AFEW-Tajikistan conducted national seminar-training for 10 narcologists in Dushanbe. (Quarter 2)

Along with provision the trainings and raising awareness of prison personnel, medical staff of prisons AFEW –Tajikistan facilitated the meetings of Partner Referrals Network and Country Penal TWG meeting with participation of all project stakeholders. These meetings were conducted on the sake of establishment of linkage, coordination of service providers and improving the quality of provided services to prisoners and ex-prisoners.

 As per lack of tests and medical specialist there was a problem of providing HCT in the prisons Uzbek minorities in prisons AFEW Tajikistan start to deliver mini-trainings on Russian and Uzbek languages. The IEC materials are also published in two (Tajik and Russian) languages which ensure easy understanding of materials.

AFEW-Tajikistan decided to provide HIV testing in the prisons settings after minitraining. There was an agreement with regional AIDS center to provide prisoners with express test and HCT. After minitraining the training participants i.e. prisoners were suggested to pass HTC on voluntary based. This effort made possible to detect HIV among prisoners and thereby decrease the number of HIV transmissions in prisons.

Transitional case management

1 Quarter – In the first quarter of project *AFEW*-Tajikistan Representative Office in Khatlon region provides START Plus services to 5 clients including 4 female ex-prisoners, 24 PLWH prisoners were reached by HIV counseling and information about available services in discharge planning period.

All 5 clients received assistance in transportation from prisons to their home places and received social packages. All 5 received pre and post HIV test consultations, they were diagnosed for TB, received the consultations of specialists of infection diseases, TB specialist.

All 5 clients trained on HIV and TB topic. All of them received food, social allowance (250 TJS) and tested for hepatitis. 2 clients received the consultations of lawyer, 2 clients were found jobs.

2 Quarter – in the second quarter of the project 7 new female clients entered into program.

All 7 clients received assistance in transportation from prisons to their home places and received social packages. All 5 received pre and post HIV test consultations, they were diagnosed for TB and Hepatitis, received the consultations of specialists of infection diseases, TB specialist. All of them were trained on HIV and TB; received food. 1 client supported in restoration of lost documents. 2 clients received the consultations of lawyer. 1 client joined OST program. 1 client received ultrasonography

3 Quarter – in third quarter 0 START Plus client was registered in report period. By official data of prisons administrations 0 prisoners will release from two pilot colonies until July 31, 2015 (Official letters №5/22- 312 from May 22, 2015 colony 3/6 Yovon and Letter №2/1-5 from May 04, 2015 from colony 3/8 Norak).

4 Quarter - 2 (1f/1m) new START Plus clients joint the program.

Both of them received assistance in transportation from prisons to their home places and received social packages. Two of them were trained on HIV and TB topics, provided with food, tested for HIV, TB and Hepatitis. 1 client received ultrasonography. 1 client received social allowance (250 TJS)

Conclusions of the Year

As the "START Plus" Transitional Client Management Program is focused on prisoners and post –release PWID, PLWH, TB patients and females AFEW –Tajikistan aimed to cover only this group of beneficiaries. Due to amnesty in November 2014 the number of released prisoners in quarters 2, 3 and 4 is considerably decreased. Therefore AFEW-Tajikistan decided to involve all ex-prisoners who need the assistance to get medical, social and legal support. Transitional Client Management Program provided clients with different services including education, counseling, IEC distribution, prerelease planning and preparedness, referrals to services, adherence, health care, social and legal

support. Within START Plus Program *AFEW*-Tajikistan worked on building the capacity of people who work in the penal system and support the expansion and scale up of access to HIV and TB testing of prisoners within the penal system, and adherence to HIV and TB treatment. For example *AFEW*-Tajikistan organized "START Plus: transitional client management program" training for 24 specialists working with pre and post-released prisoners. The training was conducted on December 2014 (Quarter 1) The participants were explained that the program begins two months before clients are released and continues with clients for four months in the community after they are released from the correctional facility. It includes six sessions of provision of information on HIV and TB, solving the housing, employment and health problems, and provision of comprehensive package of medical, social and legal support services by referrals to and using resources of civil health and social care providers within partner referral networks in regions.

The regional (Sughd and Khatlon) meetings of Partner Referrals Network and Country Penal TWG meeting with participation of all project stakeholders contribute to establishment of linkage, coordination of service providers and improving the quality of provided services to prisoners and ex-prisoners.

Also organized project monitoring and made recommendations served to improvement the work in the prisons and provision of high quality of services for ex-prisoners.

General Conclusions

Improving cooperation between penal and civil health sectors and NGOs

HIV React Project contributed on enhancing cooperation between Penitentiary System, civil AIDS Centers and local NGOs. As result of collaborative efforts of penal and civil organizations HTC services offered to 100% of prisoners in six biggest colonies of Penitentiary System of Tajikistan. It is very important that Project made possible to organize provision of HTC services to prisoners strongly on voluntary base.

Also in TWG meeting project stakeholders were introduced with joint plans of activities of Penitentiary System and AFEW Tajikistan. This effort was done to avoid the duplication of activities and cooperation between all project partners.

The coordination between civil AIDS and Narcological centers and penitentiary system has been improved. Results of project monitoring visits showed the performance of TWG recommendations. Detected HIV and/or TB patients are timely registering in appropriate centers

Improving prisoners access to HTC services

During the amnesty in November 2014 831 prisoners in two targeted prisons including 100% of released prisoners were tested for HIV and 6 cases were detected. This is the first time experience of provision of HTC services to 100% of prisoners in selected colonies.

The project introduced the innovative way of provision HTC among prisoners after mini-trainings, The invited specialists of AIDS center suggested prisoners to get HTC on voluntary based. In result 66 prisoners passed HTC and 4 new cases were detected and 10 cases were confirmed.

On the initiative of AFEW-Tajikistan there was an official appeal to MoH on introduction of HTC on the bases of POs focused on HIV area and in particular on the bases of AFEW-Tajikistan Representative office in Khatlon region. On September 30, 2015 AFEW received the official response (letter # 96/142) on positive consideration of appeal. Now, POs under the simplified procedure can be authorized to implement this service by contacting the service of state supervision over the activities of the medical centers and the State Sanitary and Epidemiological control.

Improving the level of education between prisoners and START Plus clients

As mentioned before the level of education between prisoners and START Plus program clients increased. This achievement was gained through high quality of educational materials and modules, experienced trainers and distribution of IEC materials. Also the involvement of civilian specialists who provide professional trainings to project beneficiaries contributed to improvement of the level of education.

Improvement of Web platform and IP services

AFEW supported Informational Points actively started their functioning in the report period. The number of received

and answered questions shows that such IPs is indeed necessary and people use these services. Questions can be send by anonymous senders which provides the confidentiality of person and this ensures the increase number of appliers and their interest to such services.

The project introduces institutional approaches in training of local personnel and the provision of practical assistance to prison based health care workers

By using institutional approaches *AFEW*-Tajikistan effectively spending USAID funds for developing the capacity of specialists. Instead of short term seminar for narcologists, AFEW-Tajikistan is concluded agreement with Tajik Medical Postgraduate Institute to organize one-month course for 10 narcologists. Specialists who successfully accomplish the course will be provided by official diplomas that help them to apply for increasing the professional category and salary.

Main Challenges for the Next year

Lack of START Plus clients

As per absence of released prisoners during April -September 2015, *AFEW*-Tajikistan did not cover the targeted indicator for number of prisoners joined START Plus program. In order to resolve this problem AFEW-Tajikistan decided to provide client management services to those ex-prisoners directly applied for psychosocial, economic and social support and allow them to join the program.

The turnover of prison medical workers.

There is a shortage of doctors in prisons of Tajikistan. Both targeted colonies of the project (3/6 and 3/8) have the same problem as there are no specialists with medical higher education The prisoners of both colonies are served by nursing staff. One of two solutions to this problem was to invite the specialists from civil AIDS and TB centers to participate in monitoring visits and provides necessary consultations to the primary medical personnel (nurses and first-aid man) of the colonies. *AFEW* – Tajikistan assisting to penitentiary system and civilian health services to introduce the mechanism of interaction on provision HIV focused services to prisoners living with HIV and coinfections. Pursuing this goal *AFEW*-Tajikistan is facilitated the conduction of two meetings of regional partners' referrals network were organized in Khujand, Sougd region and in Qurghonteppa, Khatlon region. The aim of the meetings was to arrange provision of continuous ARV treatment, care and support for prisoners with HIV. This effort allow to make a strong link of civilian AIDS centers (MoH) with health department of penal systems (MoJ) on provision counseling, treatment, diagnostic and support services to PLHIV in prisons. The plan of joint activities of penal and civil health organization is developed.

IP on the base of prison 3/6 in Yovon

The Information Point opened in January 2015 is not functioning at the moment. Due to prison regulations the prisoners are not allowed to use Internet. It was decided to set up the IP in the administrative part of colony. But this still did not work as the IP coordinator cannot enter to the premises as the prison administration locks the door of the premises. The solution was to keep negotiating with prison administration on effectiveness of IP for prisoners. AFEW-Tajikistan explaining the aims and objectives of the work of IP, its procedures of collection of prisoners' questions and importance of IPs services on health promotion in prisons settings for secure and reduce the harm for prisoners' health. The administration of colony promised to put to use IP for prisoners needs.
