RPO "AIDS Foundation East West Tajikistan"(*AFEW-Tajikistan*) is pleased to report on the results and achievements of the "Strengthen supportive environment and scale up prevention treatment, and care to contain HIV epidemic in the Republic of Tajikistan" Project, supported by the Global Fund to Fight AIDS, Tuberculosis and malaria, during April 01 - June 30, 2014

## **1. EXECUTIVE SUMMARY**

*AFEW-Tajikistan*'s primary achievements under "Strengthen supportive environment and scale up prevention, treatment and care to contain HIV epidemic in the Republic of Tajikistan" Project from April 01 to June 30, 2014 are as follows:

- 329 vulnerable women including 162 sex workers (49,2%) were covered with HIV prevention services during reporting period;
- 384 PLHIV were provided with quality treatment, care and prevention of co-infection services;
- 741 informational-educational materials and 25187 prevention materials (condoms) were distributed among Project beneficiaries;
- 20 peer consultants, social and outreach workers from partner organizations were trained on work with PLHIV, using Client Management method;
- 3109 people are reached by awareness raising activities, counseling and HIV information in the frame of International AIDS Candlelight Memorial Day;

# 2. PROGRESS REPORT

AFEW is proud to report on the following achievements according to 2 project objectives as shown below:

Result 1: NGO staff and selected health care workers increased the capacity to provide services on adherence and client management of people living with HIV.

#### Activity 2.1. "Client Management" trainings for NGO staff, counselors and healthcare providers.

• The 'Client Management work with PLHIV' training with participation of 20 social, outreach workers and peer consultants from10 partner organizations was conducted on May 23-34, 2014 in Dushanbe. Participants were trained on client management work with PLHIV and organizing self-help groups. External experts Mr. V. Malchikov (AFEW Kazakhstan Trainer) and Mrs. G. Mamadnazarova (Republican AIDS Centre) facilitated training.

#### Activity 2.5. Development and dissemination of Manual for local specialists working with PLHIV.

• The updated version of 'Client management on HIV prevention among vulnerable groups of population' Guide was approved for publication by Tajikistan Ministry of Health and Social Protection.

Result 2: Improved access and quality of health care and social services for people living with HIV within the pilot regions.

#### Activity 2.3. Sub-grants to CSOs working with PLHIV.

• 4 partner organizations: (NGO 'Guli Surkh' (Dushanbe), 'Orzu+' (Qurghon-Teppa, Khatlon province), 'SVON Plus' (Kulob, Khatlon province) and 'Rohi zindagi' (Chkalovsk, Sughd Province) continued their work on providing access of PLHIV to services on treatment, care, support and prevention of opportunistic diseases and co-infections. 384 PLHIV received quality services, counseling on ARV-therapy adherence and prevention of co-infection, and 118 passed TB screening and 5 cases of TB are revealed. 200 PLHIV passed CD 4 screening and 21 started ARV treatment.

#### Activity 2.4. Sub-grant for one women's center

• NGO 'Nakukor' and its partners: "Orzu+" and "Rohi zindgi" provide prevention services for vulnerable women. Altogether, they covered 329 women, including 162 sex workers. 131 (39,8%) vulnerable women passed HIV testing. 6 vulnerable women passed TB screening and new cases of TB are not revealed.

#### Activity 2.7. Awareness raising activities on improving access to services for PLHIV.

 In May 2014 "AFEW-Tajikistan" in close collaboration with regional AIDS and Healthy Lifestyle centers, local NGOs carried out awareness-raising campaign in five cities (Dushanbe, Khujand, Panjakent, Kulob, Qurghon-Teppa), devoted to the International AIDS Candlelight Memorial Day. In the course of actions, the mobile units of AIDS center provided pre-/posttest counseling and HIV testing to 156 general populations. Furthermore, three children living with HIV and 38 families affected by HIV infection were handed food parcels and hygiene kits. Overall 3109 people participated in these actions. Activity 2.8. Technical assistance and monitoring site visits.

• On April 17-23, 2014 Technical assistance and monitoring site visits was conducted to partner organizations: NGOs 'Guli surkh' (Dushanbe), 'Orzu plus' (Qurghon-Teppa, Khatlon province), 'SVON Plus' (Kulob, Khatlon province), 'Rohi zindagi' (Chkalovsk, Sughd Province) and 'Nakukor' (Kulob, Khatlon province. Partners were provided with needed recommendations on organizations' capacity building, on proper program and financial/administrative management.
