Activity 2100. One national 2-days training on adherence to ARV treatment, care and support for staff of NGOs, counselors, outreach workers and other health and psycho-social service providers

• The 'Adherence to ARV treatment, care and support' training with participation of 22 social/outreach workers and peer consultants from 11 partner organizations was conducted on March 31 - April 1, 2015 in Dushanbe. Educational activity was provided with involvement of Republican AIDS Centre specialist and AFEW trainer. Participants were trained in accordance with purposes and principles of antiretroviral (ARV) therapy to provide qualitative counseling and adherence support for PLHIV and contribute on decreasing the rate of ART interrupts. 83,8 % of post training answers among training participants are correct.

## Activity 2200. Workshops on Stigma and discrimination of PLHIV, most at risk population (MARP) and vulnerable women for 70 law enforcement officers

During the report period four Workshops for law enforcement officers were conducted by *AFEW*-Tajikistan in cooperation with the Ministry of Internal Affairs of the Republic of Tajikistan.

The first Workshop for LEO "Stigma and discrimination of people living with HIV and key populations" was conducted on April 22, 2015 by participation of 44 representatives of Ministry of Internal Affairs of the Republic of Tajikistan (22 police officers), Drugs Control Agency under the President of the Republic of Tajikistan, National Centre on Drugs Prevention and Monitoring of the Ministry of Health and Social Protection of the Republic of Tajikistan, UNDP-Tajikistan, USAID TB Control Program, NGOs: "SPIN Plus ","Guli Surkh", "Etibor", "Equal Opportunities", "Tajikistan Network of women living with HIV", "Bovary+", "Vita", "Apeiron", "Marvorid", "ROST" and Mass Media "Radio Ozodi", "Informational Agency Khovar", "Informational Agency Tajikistan". The workshop was facilitated by Hagzibekova F., Deputy of Head of the Medical Department of the Ministry of Internal Affairs of the Republic of Tajikistan.

- The second Workshop for LEO "Stigma and discrimination of people living with HIV and key populations" was conducted on May 22, 2015 in Kulob. 28 representatives of Department of the Ministry of Internal Affairs of the Republic of Tajikistan in Kulob region (16 police officers), Department of Health Region, Regional narcological Center, Regional and city AIDS Centers of the Ministry of Health and Social Protection of the Republic of Tajikistan, NGOs "SVON Plus", "Sudmand ", "Jovidon", "Nakukor" and the branch of AFEW-Tajikistan in Khatlon region took part in event. The workshop was facilitated by Hagzibekova F., Deputy Head of the Medical Department of the Ministry of Internal Affairs of the Republic of Tajikistan.
- The third Workshop for LEO "Stigma and discrimination of people living with HIV and key populations" was conducted on July 10, 2015 in Qurqhonteppa. 26 representatives of the Ministry of Internal Affairs of the Republic of Tajikistan and Department of the Ministry of Internal Affairs of the Republic of Tajikistan in Khatlon region (17 police officers), Regional AIDS Centers of the Ministry of Health and Social Protection of the Republic of Tajikistan in Khatlon region, NGOs "Fidokor", "Orzu Plus", "Akhtari bakht", "Sino", "Subhi tandurusti", "Tomiris" and the branch of AFEW-Tajikistan in Khatlon region took part in event. The workshop was facilitated by Hagzibekova F., Deputy Head of the Medical Department of the Ministry of the Republic of Tajikistan.
- The fourth Workshop for LEO "Stigma and discrimination of people living with HIV and key populations" was conducted on August 21, 2015 in Khujand. 29 representatives of the Ministry of Internal Affairs of the Republic of Tajikistan and Department of the Ministry of Internal Affairs of the Republic of Tajikistan in Suhgd region (19 police officers), Regional narcological Center and Regional AIDS Centers of the Ministry of Health and Social Protection of the Republic of Tajikistan in Suhgd region, NGOs "AntiAIDS", "Rohi zindagi", "Hayoti nav", "Ikboli nek", "DINA", "VITA" and initiative group "Khujand" took part in event. The workshop was facilitated by Hagzibekova F., Deputy Head of the Medical Department of the Ministry of Internal Affairs of the Republic of Tajikistan.

During abovementioned workshops the representatives of local NGOs presented and discussed with police officers information about their work on HIV prevention among vulnerable groups and client management of PLHIV. Also, the issues of reduction of stigma and discrimination of vulnerable groups of population were discusses during the meetings. Participants of the workshops familiarized with the Instruction of the Ministry of Internal Affairs RT on organization of HIV prevention work and health safety at working place. AFEW-Tajikistan presented its video spot about the human rights of PUDs to participants of the Workshops.

## Activity 2300. Provide methodological assistance and sub-grants to NGOs working with PLHIV and vulnerable women throughout the country (such as cities, oblast centers, other densely-populated areas)

*AFEW*-Tajikistan transferred sub-sub-grants to five NGOs ("Guli Surkh" and "Tajikistan network of women living with HIV" (Dushanbe), "Orzu Plus" (Qurqhoonteppa), "SVON Plus" (Kulob) and "Rohi zindagi" (Khujand and Isfara)) which have experience of joint work, capacities to provide services for final beneficiaries and interacting with local health and social service providers.

During report period 852 PLHIV were covered by peer counseling, ART adherence support, IEC, condoms and prevention materials. 547 or 64,20% from 852 PLHIV reached by Project passed TB screening. 0 new cases of TB were detected. 649 or 76,17% from 852 PLWH reached by Project passed CD 4 diagnostic. As result 120 PLHIV started ARV treatment. 538 PLHIV started the ART treatment before the realization of this project. 70 PLHIV interrupted ART treatment. Eight of dropped out patients are died. Left 62 PLHIV were reached by IEC materials, pre-treatment readiness and ART counseling of peer counselors and social workers of NGOs. As result, 50 from them are initiated follow up ART treatment and passed for supervision of AIDS Center's specialists. At the end 12 of dropped out patients still didn't return back to treatment.

At the same time, 750 vulnerable women including 469 (62,53%) sex workers covered by comprehensive package of HIV prevention services of sub-sub-grantees. The package of project services is including HIV and STIs education, HIV counseling and testing, IEC, condoms, and distribution of prevention materials. 66,27% or 497 from 750 vulnerable women reached by Project are passed HIV testing. 1 case of HIV was detected. 73 vulnerable women referred to TB counseling and received TB diagnostic. 0 new TB cases were detected.

# Activity 2400.\_Awareness raising activities on improving access to services for PLHIV through conducting advocacy and awareness raising activities

During May 17-23, 2015 *AFEW*-Tajikistan supported initiatives of NGOs "Guly Surkh", "Tajikistan Network of women living with HIV", "Orzu plus", "SVON Plus" and "Rohi zindagi" and the *AFEW*-Tajikistan Representative Office in Khatlon region to organize advocacy events devoted to the International AIDS Candlelight Memory Day and to raise awareness of local communities about HIV. In close collaboration with regional AIDS centers the local NGOs carried out awareness-raising campaigns along with dissemination of information materials among population of five cities (Dushanbe, Khujand, Isfara, Kulob, Qurghon-Teppa). During the actions, the mobile units of AIDS center provided pre-test counseling and HIV testing for 93 general populations in Khujand and Qurghon-Teppa. 0 new cases of HIV have been detected.

Furthermore, within events devoted to International AIDS Candlelight Memory Day in Dushanbe, Kulob and Qurghoonteppa the set of food kits were distributed for 32 poorest families affected by HIV and AIDS.

Overall 2999 people participated in the actions devoted to the International AIDS Candlelight Memory Day.

# Activity 2500. Technical assistance and monitoring site visits to track the quantitative progress of sub-grantees as well as to evaluate the quality of provided services to beneficiaries.

On May 18-26, 2015 and on September 02-08, 2015 two monitoring visits have been conducted by *AFEW*-Tajikistan. Partner organizations provided with practical assistance on organization of client management services for final beneficiaries and verifying project data. Monitoring held in NGOs 'Guli surkh' and 'Tajikistan Network of women living with HIV' (Dushanbe), 'Orzu plus' (Qurghon-Teppa, Khatlon province), 'SVON Plus' (Kulob, Khatlon province) and 'Rohi zindagi' (Chkalovsk, Sughd Province). Essential recommendations on improving program, administrative and financial management have been passed to sub-sub-grantees.

UNDP National consultant on ART and care also took part at monitoring visits.

### Describe other success stories not reflected in the quantitative data:

HIV positive Kurbonbi, 34-year-old young woman, after divorcing her husband, left without support, without job and house and had to return with her five-year son to her parents' house, where nobody was waiting for her. Her relatives did not know about her HIV status. Coming back home was another test for Kurbonbi. She had a hard time because of the constant conflicts with her relatives who did not need dependents. She hid receiving the ARV because she was afraid that the family get to know of her HIV-positive status and will kick her out of the house. Hiding the treatment and taking the medicines Kurbonbi do not take them in time disrupting her treatment. And regular visits for getting medication at AIDS center was another stress for her. During a visit to the AIDS center Kurbonbi met with the consultant of "Tajik network of women living with HIV" and told her about her problems of living with HIV. Consultant invited Kurbonbi to their organization, where they discussed the issues of adherence to ART and provided her with legal advised. Social workers continuing to provide support for treatment adherence; found an HIV-positive man, who responded to the request of Kurbonbi. It turns out that he also wanted to start a family with HIV-positive woman, but was afraid to talk about it to anyone. Young people met each other and at the first meeting realized that they could trust to each other. After a while they got married

• "HIV-positive women primarily need psychological and social support. Usually the relatives of husband and the parents of HIV-positive women kick them out of the house, once they got to know about their HIV status. Cooperation efforts with the public services we provide women with demanded social and legal services in crisis situations"- says Takhmina Khaydarov, the head of the" Tajik network of women living with HIV ":

With the help of consultants and social workers in the life of Kurbonbi appeared a man who supports her and her child. Now they live separately from Kurbonbi's relatives. Kurbonbi is happy to take ARV without fear and grateful for that meeting, when an employee of the organization handed her a helping hand. Kurbonbi began to attend self-help group and is always ready to help others

• "Before, it was difficult to me to fight for life. There was no one whom I could trust, and there was not strong shoulder to rely. Meeting with women with the same problems as me, I found a loving man and start a family. I am very happy"- says Kurbonbi.

*AFEW*-Tajikistan will continue work on introducing VCT service on the basis of NGOs. Starting from May, 2015 *AFEW*-Tajikistan is initiated the process of negotiations with the Ministry of Health and Social Protection on finding possibilities to introduce VCT service on the basis of NGOs. As result of bilateral consultations, the Ministry positively responded to AFEW-Tajikistan request and by its

Order # 832 dated September 30, 2015 permitted to local NGOs to provide VCT services to key populations by themselves.
